## World Health Day 2015 Safe food is the precondition of healthy life

The World Health Day is observed globally on 7th April every year. as t all over the globe. This year's theme is 'Food Safety'. The government of Bangladesh is observing the day with the slogan "Nirapod Pushtikor Khabar, Sustho Jiboner Angikar" (safe, nutrient food promises healthy life).

Food is one of the fundamental rights of people. The constitution of Bangladesh in section 15 (a) says "It shall be a fundamental responsibility of the State to attain, through planned economic growth, a constant increase of productive forces and a steady improvement in the material and cultural standard of living of the people, with a view to securing to its citizens—the provision of the basic necessities of life, including food, clothing, shelter, education and medical care".

TIB's report titled 'Ensuring Safe Food: Governance Challenges and Way Forward' (2014) recommended to taking some effective initiatives to ensure safe food in Bangladesh, which included, among others:

- Amendment of Safe Food Act 2013 and its quick implementation
- Provision of legal actions by consumers
- Amendment of the Consumer Rights Protection Act 2009 and
- Establishment of food courts at all districts and metropolitan cities.

Unsafe food is one of the main causes behind people's health problems all over the world. To create a healthy, beautiful world we all need to be aware and particularly the government should take effective measures to solve the problems giving special priority on this issue.

### Rampal and Matarbari Power Projects: Governance Challenges in Environmental Impact Assessment and Land Acquisition

A TIB study titled "Rampal and Matarbari Power Projects: Governance Challenges in Environmental Impact Assessment and Land Acquisition" found major breaches of laws, ordinances and regulations in the land acquisition and environmental assessment processes of the two projects. The study was released on 16 April 2015 at the Conference Room of TIB.

According to the report, the Environmental Impact Assessments (EIAs) of both Matarbari and Rampal projects are flawed and replete with corruption. There are obvious evidences of conflict of interest, law violations in the Department of Environment (DOE) approval, ordinance and regulations violation regarding site clearance, inadequate public participation in the stages of project planning and implementation, carelessness on human and environmental issues, neglected ash pollution and pollution caused by coal transport through the Sundarbans, neglected water withdrawal and discharge impacts, un-implementable employment plans, illegally and unethically concealed information as well as falsifications and manipulations of scientific findings in both the projects.

The study highlighted some of the impacts caused by fallacious EIAs and land acquisition processes. Improper EIAs weaken Bangladesh's demand for climate finance and generate inaccurate cost-benefit analysis. Similarly, improper land acquisitions displace a significant number of families, increase poverty levels and create risk of mass protest against the project (power plants).

TIB made seven recommendations to neutralize and ameliorate the situation that has resulted from rampant corruption in the Matarbari and Rampal coal fired power plant projects. Please visit www.ti-bangladesh.org for more details.

# TIB recommends 10 measures to overcome challenges and to ensure good governance in garment sector

Although notable progress has been achieved, however, various deficits still exist indicating that a lot needs to be done to consolidate reforms gained in establishing good governance in the country's Ready-made Garment Sector (RMG) sector, a TIB study revealed. The study "Good Governance in the Ready Made Garment Sector: Review of Progress during Last One Year" released on 21 April, assessed the progress and implementation status of different initiatives undertaken to ensure good governance in RMG Sector in the last one year (April 2014 to March2014).

In October 2013, TIB conducted a research that identified some causes of such accidents and lack of compliances in RMG sector that included coordination gaps among relevant stakeholders and their negligence of duties, political influence, and irregularities and collusive corruption between regulatory agencies and factory owners. TIB also conducted a follow-up study on the first anniversary of the accident in 2014 to assess progress of

initiatives undertaken numerous bv various stakeholders in the aftermath of Rana Plaza accident. As part of continued follow-up, TIB undertook the present research on the occasion of the second anniversary of the accident to assess progress of remaining and new initiatives during 2014 -2015. According to the second follow-up study, 56 issues were considered for assessing progress and implementation status of various reforms initiatives. It discarded seven issues that were covered in 2014 study. Out of 56 issues, no initiatives were taken on 8 issues in the last one year, leaving 48 issues for assessment under current research. It is observed that 80 initiatives covering those 48 issues were undertaken, of which 15% were implemented completely, 45% made considerable progress and 15% showed slow implementation and 25% made no notable progress.



The study highlighted major progress of the government-initiated projects, which included, among others, amendment of EPZ law, 2013; appointment of panel lawyers to help workers in the labor tribunal, finalization of labor rules and preparation of guideline for sub-contract factories, formation of two taskforces to monitor inspections carried out by Accord and Alliance. It also made progress in the anointments of staff to enhance the capacity of Director General of Factory and Establishment and Fire Service, including realization of decentralization process of Director General of Factory and Establishment and RAJUK.

According to the study findings some 85% of the financial assistance deposited into the Prime Minister's Relief and Welfare Fund for the victims of the Rana Plaza is yet to be disbursed two years after the world's worst workplace disaster. The Fund received about \$16 million or Tk 127 crore from local sources, mainly commercial banks, for the victims and their families since April 24, 2013. But about Tk 108 crore of the Fund remained unused, the study said.

TIB put forward a set of recommendations on this sector and also suggested releasing name of partnering factories in Bangladesh on website of every buyer and quick settlement legal cases relating to Rana Plaza collapse. Please visit www.ti-bangladesh.org for more details.

#### A production-based Theater Workshop held

A production-based Theatre Workshop for Dhaka YES Theatre Group was held on 25-30 April in Dhaka. 18 YES members from different YES Groups participated in the workshop. Prof. Yusuf Hassan, Department of Drama and Dramatics, Jahangirnagar University; Sudip Chakroborty, Chairman and Assistant Professor, Department of Music & Drama, University of Dhaka; Mahmuda Akhtar recitation artist; theatre activist Muhammad Shahinur Rahman and Mohammad Ishaque Faruqee joined the workshop as facilitator of the five-day long workshop.

The improvised drama centers on land grabbing and occupying water bodies by powerful quarters in Dhaka metropolis. It also highlighted cases of unauthorized payments in the cases of land registration and mutation where public sufferings have become a norm and a way of life. The connivance of the officials with the politically powerful and absence of rule of law, accountability and transparency in land sector was also depicted, much to the cheer of the crowd.

The recommendations were presented in a programme titled 'Measures to be taken at the local level to improve transparency and accountability in primary education sector' organized by CCC Madhupur with the support of the Upazila Education Office of Madhupur held on 11 April.

The key recommendations included, among other, ensuring stipend for 100% students; arrangement of Tiffin for the students in school; depositing allocations directly to the account of the school; setting teacher-student ratio as 1:30 and ensuring transparency in recruitment process at all level of the school.
