

Economic Research Group and Member, BDIX Trustee Board.










Atiq Rahman, PhD, is the Executive Director of Bangladesh Centre for Advanced Studies and in-charge of Programme and Policies of BCAS. He also coordinates Global Forum on Environment and Poverty (GFEP), which is an initiative emerging out of UNCED in Rio, and a worldwide network of over 400 policy and research institutes working on sustainable development, global governance and equity issues. Further Dr. Rahman is the Chairman of the Executive Board of Climate Action Network – South Asia (CANSA), a South Asian Network working on Global Change, working closely on global change issues and global networks. In 1999, he was elected as the Chairperson of the Coalition of Environmental NGOs, Bangladesh and continues to represent this



vibrant community as its principal mover and shaker. He was the Team Leader of the National Adaptation Plan of Action (NAPA) Synthesis, Government of Bangladesh. Dr. Rahman is a leading Environment and Development Specialist with wide national, international and global experience and involvement in Sustainable Development, Environment and Resource Management, poverty and equity, disaster management, people's participation, global governance and modeling evaluation issues. He is a well recognized global leader in sustainable development. He was the lead author of the IPCC Fourth Assessment Report, which received Nobel Peace Prize in 2007. He was a recipient of this Nobel Peace Prize with other scientists. He was awarded the UN Highest Award for Environment "Champions of the Earth 2008". This award recognizes "the extraordinary leadership and his contribution to environmental issues, sustainable development and climate change. He has also received "Environment Padak -2008" for research and technology innovation by the Government of Bangladesh, the highest official recognition for outstanding contribution in the field of environment. He has been teaching at Fletcher School of Law and Diplomacy, Tufts University, Boston, USA as the Visiting Professor of International Diplomacy and Sustainable Development. He is also the Bangladesh Focal point of South Asian Poverty Commission follow up actions. Trained as a chemist having education in B.Sc Hons. and M.Sc from Dhaka University, he was awarded the Commonwealth Scholarship 1974 and completed his Ph.D on solid state chemistry and low energy processes from Brunel University, London, UK. in 1977. For fourteen years (1974 -1988) he taught and researched in the Oxford and Aberdeen universities in the UK and the Haute Alsace in France.

Fazle Rabbi Sadeque Ahmed holds PhD in Environmental Science from the University of Aberdeen, UK in the year 2005. He has been worked as Project Coordinator, Community Climate Change Project of PKSF, under Bangladesh Climate Change Resilience Fund since 2012. Prior to that he had worked as Director (Climate Change and International Convention) in the Department of Environment from 2009 to 2011. He was a member of Bangladesh delegations in several international climate change negotiation including COP 15 in Copenhagen and COP 21 in France. He has aso been working as



an adviser of Green climate fund board for the last the two years. He has several papers, book chapters, briefing papers, and key note key-note speaker his credit. He is also an Adjunct faculty of several training institutes. As a member of technical committee, he had contributed to several national documents such as NAPA, INDC, Climate Fiscal Framework etc.

Firdaus Ara Hussain is a development expert working in various capacities for over 10 years and is currently engaged as Principal Advisor-Climate Finance Governance Project of the Climate Finance Governance Project and Implementing Advisor of the CF Ready Programme in GIZ Bangladesh. Gawher Nayeem Wahra has over 28 years of experience, managing complex emergencies and natural disasters at local, regional, national and international levels. He has played managerial roles in developing community-focused humanitarian response and human rights-based resources for right-based humanitarian actions, monitoring and coordinating in various development organisations. Iftekharuzaman, PhD, is Executive Director of Transparency International Bangladesh (TIB). He served earlier as Executive Director of Bangladesh Freedom Foundation (1999-2004), Executive Director of Regional Centre for Strategic Studies, Colombo (1995-99) and Research Director of Bangladesh Institute of International and Strategic Studies (1982-95). He was educated in the University of Dhaka and Academies of Economics, Wroclaw and Warsaw. He was a post-doctoral fellow in International Relations Department of University of Tokyo



(1988-89). Dr. Zaman was elected to the International Board of Directors of TI in 2008, reelected in 2012 and for the third term in 2015. He is the Chairperson of Acid Survivors Foundation; Trustee of Bangladesh Freedom Foundation, Manusher Jonno Foundation and Bishwa Shahityo Kendro; and Member, International Commission on Chittagong Hill Tracts. He was the first individual from the developing South to be elected as Chair of the International Committee of the Washington DC-based Council on Foundations. Main areas of his current interest and expertise are governance, anti-corruption, people's engagement, social accountability, politics, development, regional security and cooperation, on which he has written and published widely in and outside Bangladesh. In recognition of his leadership in advocating against corruption and promoting transparency and good governance, Dr Zaman was awarded the first Global Partnership Forum for Social Accountability (GPSA) Award in May 2015. The award acknowledged his role to catalyze institutional, legal and policy reforms and application of participatory social accountability engaging volunteers, particularly youth, in such vital sectors as education, health and local government.

Kazi Maruful Islam, PhD, is serving as a Professor of Department of Development Studies, University of Dhaka. He has served as the team leader of 'Climate Change, Food Security and Governance Unit' of Eminence. Before joining as Chair of DESM at NSU in early July 2003, he served for four years as UNDP Environment Policy Specialist, working with the Govt. of Bangladesh. In the early 1990s, he worked for 3 years as a Senior Researcher at the Centre for International Development and Conflict Management (CIDCM) at the University of Maryland at College Park. He was Vice Chair of the LDC Expert Group under the UNFCCC during 2002-2004. He attends climate negotiations as the lead negotiator on climate finance with the Bangladesh delegation since 2001. Dr. Khan is the Focal Point of the Nairobi Work Program of the UNFCCC representing the Academia in Bangladesh. He is an invited speaker in global







expert meetings on climate change. He worked as Project Director of a 6-year CIDA-funded Partnership Project (2007-2013) with the University of Manitoba, Canada, on "Building Environment Governance Capacity in Bangladesh."


