## Graft Liability of illicit earnings: Conscious and empowered Women can safeguard family

To awaken women regarding liability of illegal earnings and assets acquired especially by male relatives through corruption and accept deposit in their names either willfully or unknowingly, it is important to grow consciousness among women about the legal obligations and the definite punishment of such criminal acts. Such awareness raising programmes should highlight the potential risks of the crime, ways to avoid and the prevailing laws for safeguarding them and the family in this regard. Besides, more policy research and studies should be conducted to determine either the women are deliberately engaged with the liability or compelled to agree with the settlement. Relevant institutions should take initiatives of providing legal assistance to the female victim of such grafts. Moreover, Anti-Corruption Commission should be more sensitive and female-friendly in searches, investigation and prosecution of relevant corruption cases.



The observations were provided by the participants of an opinion-sharing meeting titled family liability of illicit income and property through graft: the role of women, risks and way forward held on 6 May 2018. Transparency International Bangladesh (TIB) organized the event at its Dhaka Office to analyse the risks posed to family especially women as wives in addressing liability of illicit income and property acquired through graft with its legal, institutional and socio-economic impact, and identify ways forward.

Moderated by TIB Executive Director Dr. Iftekharuzzaman, Mr. Iqbal Mahmood, Chairman, Anti-Corruption Commission (ACC) attended the event as Guest of Honor.

At the beginning of the event, TIB Programme Manager Shammi Layla Islam presented a working paper in the meeting where ACC was urged to adopt more women friendly measures in examining and investigating corruption charges against women. According to the paper, to safeguard earnings and assets acquired through graft, the prevailing practice of keeping the incomes in women's title is a common phenomenon in Bangladesh to avoid the liability. In most cases, women get victimized for the wrongdoing unknowingly which push them towards a different type of social risk. Patriarchal socio-economic context, economic dependency and sympathetic attitude of women towards family, corruption-prone mentality stretch the hazard further. In preserving the illegal earnings and assets of husband, brother or any other male relative, women often forcibly become victim, means, beneficiary of the corruption and sometimes turn out as collaborator of fraud and thus become liable and criminal in eyes of law. The paper also recommended for providing legal support to women who will fall prey to corruption charges. According to the paper, the court punished 29 women in the 29 cases filed by the ACC from March 2007 to March 2018 for helping their



husbands in carrying on corrupt activities. Moreover, there are 118 cases filed from 2015 to 2017 where corrupt persons acquired illegal wealth in their wives' names. To counter and prevent the prevailing risk



crime, speakers stressed on active role of conscious, aware and vigilante women for meaningful change. Besides, women's increasing inclusion in decision-making process, of traditional change

patriarchal concepts, exemplary punishment and effective prevention of corruption, and governments political will for these changes can gradually decrease the risk.

Mr. Iqbal Mahmood said a good number of women to their unawareness own illegal wealth which was basically obtained with illicit income by their male relatives like husband, father or brother. In around 90 per cent of the cases filed by the commission women have no knowledge that the assets they own actually

came from illicit income of their male relatives, he said. "The ACC will talk with lawmakers about whether it is possible to punish a woman who did not know anything about her husband's involvement in corruption. It'll also consider whether it's possible to amend the law in this regard," he added. However, ACC has been thinking how to provide safeguard to these women with the existing



legal framework and raising awareness among women about that type of situation so that they can stand against corruption, he said. Besides, women empowerment, increasing number of women inclusion in decision-making process, awareness raising programmes, further discussions with stakeholders will be needed to counter this prevailing menace, he added.

Dr. Iftekharuzzaman said "anti-corruption awareness can play meaningful role in these cases where ACC needs to play a more powerful and engaging role. In safeguarding family, there is no alternative of being aware and conscious. However, to measure the level of women's actual involvement with the liability of illicit incomes and property acquired through graft, further research and study should be conducted. Women empowerment and advancement will be of big help in preventing and reducing corruption in society."

The meeting was also addressed by TIB Adviser-Executive Management Professor Dr. Sumaiya Khair; ActionAid Country Director Ms. Farah Kabir, Bangladesh Nari Progati Sangha (BNPS) Executive Director Rokeya Kabir; Professor Asif Nazrul, University of Dhaka; Political Scientist Professor Dilara Choudhury; Manusher Jonno Foundation (MJF) Executive Director Ms. Shaheen Anam and others. Among others, senior



officials of ACC, representatives from relevant government and non-government organizations, journalists from print and electronic media also attended the event.

#### TIB to government: repeal section 57 and review proposed new draft act

TIB called on the government to review nine provisions in the proposed Digital Security Bill and the scrap controversial Section 57 of the Information and communication Technology Act 2006 to ensure freedom of expression and the press. In a statement released on 2 May marking World Press Freedom Day, the antigraft organisation urged the parliamentary committee to move ahead with adequate consultation with relevant stakeholders including media activists, so that the media workers can enjoy their constitutional rights and people can express views as entitled in the constitution.

Mentioning the proposed Act as contradictory to the constitutional right of freedom to express and the ideology of the Liberation War, TIB Executive Director Dr. Iftekharuzzaman said, it will generate greater risk of insecurity not only for expressing opinion freely but also for practicing basic human rights of both the media workers and mass people if the act comes into effect without proper reviews. Section 57 has already created distress among the social media users and mainstream media activists ensuing in self-censorship, which is an obstacle of people's right to express, Dr. Zaman said.

Dr. Zaman also conveyed his disappointment at placing the draft Act before Parliament without making amendment to it despite widespread concerns among the stakeholders. It would be absolutely impossible to publish anything on misuse of power, including various types of irregularities and corruption, and such crimes would thrive under the protection of law, he said. If the bill becomes law, it will not only affect freedom of expression but also increase the risks of exposing citizens to insecurity by curbing their fundamental human rights, he added.

Dr. Zaman said, the proposed act is being formulated in the name of ensuring digital security. But in fact it will make the freedom of expression insecure as well as make the basic exercise of human rights for media personnel and mass people vulnerable, exposing various irregularities and anomalies to public would become impossible (due to these sections), and these would ultimately work in favour of misusing power and spreading corruption, Dr. Zaman noted.

Besides the government, the role of the people, civil society and mass media is immense for achieving the targets of the sustainable goals, Dr. Zaman concluded adding that "a fair environment has to be ensured so that people, including mass media, can express their opinions without fear and can assist the government".


## Parliament Watch observed lack of expected role in promoting democratic accountability

Although attendance of MPs in the Parliament and average time spent for each session increased in the 14th to 18th session of the 10th parliament, there remain many challenges to make the Parliament more effective. Quorum crises still remains same as previous year and total amount of time spent in enactment of law remains still very low (9% of total time). Besides, the continuous trend of using unparliamentary language and violations of the Rules of Procedure by the MPs, failure of the main opposition party in playing effective role in making the government accountable, low participation of female members' in legislative





and other discussions with additional other findings presented a miserable picture containing lack of expected effectiveness of the parliament in promoting culture of democratic accountability through



preventing corruption and establishing good governance in the country. These observations were stated in the current issue of TIB's analytical research report Parliament Watch, fourth of its kind on the 10th Parliament and the 14th of the Parliament Watch (PW) series.

The report suggests to take necessary steps to retable and enact the MP's Code of Conduct Bill with required update and stresses on stronger role of the Speaker to stop the trending use of unparliamentary language and behavior. Among other important recommendations, the report includes: call for consideration of legitimate and reasonable proposals raised by the opposition; collect public opinion on draft bills through various accepted procedures; publishing of all information related to the Parliamentary activities in the Parliament website; provide due importance to recommendations of the Committees and implement accordingly.

To reveal the report findings and recommendations, a Press Conference was organized by Transparency International Bangladesh (TIB) at Dhaka office on 17 May 2018. TIB Chairperson Advocate Sultana Kamal, Executive Director Dr. Iftekharuzzaman, Adviser Executive Management Professor Dr. Sumaiya Khair,



Director-Research & Policy Mohammad Rafiqul Hassan were present at the press conference. TIB Deputy Programme Managers Nihar Ranjan Roy and Morsheda Aktar with Assistant Program Manager Amit Sarker of Research & Policy division presented the summary of the report accompanied by Program Manager Juliet Rossete.



According to the report, average quorum crisis of working time of the session on each working day was found comparatively same to previous year (13% quorum crisis of total time, the monetary value is estimated around BDT 37 crores). Total amount of time spent in enactment of law remains as low as previous year (9%), the practice of not considering people's participation and opinion of opposition members exists. Despite increased presence of the female members than male members, participation in legislative and other discussions found relatively low. Activities of committees such as cconflict of interest of some standing committee members and irregular meeting of the standing committees result violation of rules, and lack of not paying due importance by ministries/divisions in some cases towards recommendations proposed by the standing committees bar expected level of effectivity of the committees. The report also indicates that the main opposition party continue to fail in establishing accountability of the government.

Expressing concern on continuing trend of quorum crisis and increasing practice of using unparliamentary language at the parliament, Dr. Iftekharuzzaman said, "Both the government and the opposition are responsible for the failure of the parliament in promoting democratic accountability and preventing corruption for improving governance in the country. The party which claims to be the opposition party of the house itself lies in crisis regarding self-identity." Pointing the importance of parliamentary committees in playing on people's side to make the parliament accountable Dr. Zaman said, "deficiencies in some part of the committee's effectiveness were observed mostly due to conflict of interest of the leading committee members with the relevant featured issues which bar the committees in addressing primary duties."



Citing growing trend of not presenting international agreements through the honorable President in the parliament, Advocate Sultana Kamal said ''Before finalizing any agreement or treaties with other countries, it is sensible to bring it in the parliament and go ahead after open discussions and debates in the parliament for the betterment of the people and the country."

In view of parliament's paramount

importance in promoting culture of democratic accountability for preventing corruption and establishing good governance in the country, TIB has been conducting PW study since 2001 from the beginning of the 8th Parliament. The overall objective of this research was to analyze the roles and proceedings of 14th to 18th sessions of the 10th Parliament in ensuring democracy and good governance and offer recommendations for making the parliament effective. The study used both quantitative and qualitative methods for collecting data on the parliament from both primary and secondary sources. The study also explored parliamentary openness on the basis of some international and practices that includes SDG targets regarding public access to information and IPU and PMO pleas on information dissemination by parliaments and other good practices.



# International debate on Climate Finance and Governance: Engaging the Youth for Transparency, Accountability and Integrity

Focusing on effective climate finance and good governance of climate funds, young debaters stressed on democratizing the governance and administration of climate finance. Core governance principals included transparency, accountability and integrity at various levels ranging from policies and practices with regard to disbursement of committed funds, challenges in the process of disbursement and various stages of use of disbursed funds including project implementation. Following the Paris Agreement on climate change as well as national legal regime citizens including vulnerable community have a right and an obligation to be informed about and involved in how public money is utilized, the young debaters argued that for effective, efficient and equitable concrete mitigation and adaptation, gender-equitable citizen's participation in decision-making should also be ensured in mobilization of public climate funding, as the International Debate on Climate Finance and Governance - Engaging the Youth for Transparency, Accountability and Integrity concluded in 13 May 2018 at the Studio of Channel I at Dhaka, Bangladesh.



Organised under the climate finance governance programme of Transparency International Bangladesh (TIB), young debaters from Nepal, Bhutan, Srilanka, Maldives, Indonesia, Cambodia and Bangladesh, the most climate vulnerable countries participated in the two-day debate competition. Eight teams participated from above countries and two teams from Bangladesh which are Institute of Business Administration (IBA) of University of Dhaka and North South University, teams from Sri Lanka and Cambodia qualified for final debate. Finally, North South University Team became the Champion and IBA Team as runner-up. The competition was conducted in the British parliamentary style where Debater Sadman Karim from North South University was awarded as the Best Debater of the competition.

In his speech of the Chief Guest, Barrister Anisul Islam Mahmud, Hon'ble Minister for Ministry of Environment and Forest said, "industrially developed and rich countries who are liable for climate change are trying to provide compensation as loan instead of grants in countering climate change impact." He added, "in climate finance and project implementation, accountability and integrity are also equally essential along with transparency. Considering limited resources, it is also crucial to develop climate adaptation projects in a trust-based manner including transparency, consideration of ground-realities, sufficient knowledge on relevant best practices and lessons, and importance of the subjects."





TIB Executive Director Dr. Iftekharuzzaman said, "TIB believes that youth involvement in climate finance and adaptation activities will enhance overall excellence of the process. This competition is organized to understand youth observation and approach on these issues and inspire youth participation in the process. TIB continues its effort to establish democratic principles in the sector. Countries like Bangladesh, adversely hit with climate change implications has considerable right to get the required compensation for adaptation, mitigation, and cover the devastated losses and damages. We strongly demand that sufficient compensation will be provided by the liable countries for climate change to the climate-hit countries."





In the final round, eminent media personality and former debater Dr. Abdun Nur Tushar attended as the Speaker. Barrister Anisul Islam Mahmud, Honorable Minister of Environment, Forests and Climate Change was present as the Chief Guest at the event, accompanied by TIB Executive Director Dr. Iftekharuzzaman and Adviser-Executive Management Professor Dr. Sumaiya Khair.

The final round was later telecasted on 15 May 2018 at the Channel and the recorded event is available at TIB website and social media channels.

## TIB airs concern on reported 'Gunfight' in anti-narcotic drive, seeks judicial probe

Expressing concern over the deaths of a large number of alleged `drug traders' in the ongoing anti-narcotic drive, TIB termed the deaths `unconstitutional' and sought judicial inquiry into the killings in the drive questioning the explanation of law enforcement agencies in this regard. The graft watchdog expressed worry on the use of excessive force by law enforcers fearing the trend would deprive the citizens of their constitutional rights to security and further escalate the risk of institutionalizing the culture of breaking laws.

Saying that the constitution has given every citizen the right to get justice in a statement released on 31 May 2018 TIB Executive Director, Dr. Iftekharuzzaman questioned the legal acceptability of the government's interpretation of the drive. "Also, the way listed criminals are being killed in gunfights before being convicted through proper trials is completely unconstitutional and though these incidents are being explained as countermeasures for self-defense, there are no legal processes to ascertain their authenticity."," he said.

Dr. Zaman said, "It seems that mostly low-profile field-level drug peddlers and druggies are becoming victims of gunfights. Many of those could have been valuable informants to address the drug menace. There





is no proven method of controlling drugs or preventing crimes through gunfights in the entire world. Rather, if the enlisted people are sent to trial following prevailing law and the godfathers of the supply chain can be identified and brought under justice, the objectives of the drive can be achieved."

Pointing to the burgeoning tendency of violation of laws by the law-enforcement agencies under government's patronage, Dr. Zaman said it will affect the overall human rights situation of the country. The way violations of the law are being informally validated by law enforcement agencies is downright alarming for the country's justice, governance, and democracy, he concluded.

## TIB seeks government's response on ICC move regarding Rohingya atrocities

TIB urged the Government to submit its observations with available information and documents concerning crimes against humanity against the Rohingya people by the government and military of Myanmar in response to the call of International Criminal Court (ICC). Bangladesh's cooperation will increase the prospect of justice for the human rights violations against Rohingya people by Myanmar military as well as will help to create international pressure on Myanmar and the countries active on international platforms for protecting Myanmar interests, TIB observed in a statement carried on 29 May 2018.

A pre-trial chamber of the ICC recently sought documents and opinions from Bangladesh about the court's jurisdiction over the expulsion of Rohingya people from Rakhine in Myanmar. Referring to media reports, TIB mentioned that the government of Bangladesh is still in confusion regarding response to the ICC letter.

Terming the ICC's initiative to investigate and prosecute the crimes of deporting and killing of Rohingya's a ray of hope, TIB Executive Director Dr. Iftekharuzzaman hoped Bangladesh will gear up the process through its clear stand. He said, "It would be a significant action for Bangladesh to take as a people and a nation that had suffered horrific war crimes during its liberation war of 1971, which went unaddressed for too long. Undoubtedly Bangladesh's response would strengthen ICC's move."

Dr. Zaman said the Myanmar regime and a section of the international community 'are responsible' for imposing the burden of about one million Rohingyas on Bangladesh. 'As a member country of ICC, Bangladesh can play important role in bringing the perpetrators of mass atrocities to account. As a result, a historic opportunity will be created for accountability of the international community, including the United Nations, which has been playing a role of silent spectator in the preparation period of ethnic cleansing by Myanmar's armed forces."

# TIB calls for more transparency in the 2018-19 Budget proposal

TIB sought more transparency in the upcoming budget proposal. In a statement carried on 15 May 2018 the anti-graft watchdog urged for suspension of black money legalization opportunity, keeping prospect of interpretation and discussion on allocation against defense forces in the budget speech, allocation of minimum BDT 300 crore for the Bangladesh climate change fund (BCCTF). It further demanded that no bailout fund and scopes for rescheduling defaulted loans by willful defaulters should be kept in the upcoming budget for the scam-hit state-owned banks. It further urged to keep sufficient allocation for Anti-Corruption Commission (ACC).

In a statement ahead of the national budget, TIB Executive Director Dr. Iftekharuzzman noted that allocating controversial bailout fund in the budget for 2018-19 would be 'state incentives' to





loan defaulters and masterminds of scams. He criticized legalizing black money as unconstitutional and immoral as well as discriminatory and corruption-prone under state patronage.

Dr. Zaman said, "The will, mentioned in the proposed draft national defense policy to take the armed forces closer to the people can be accomplished if the people get access to details of defense budget and expenditure to ensure transparency and accountability thus gain more public support." Expressing concern on peoples declining trust upon banking system, Dr. Zaman said, "the damage could surround the entire economic system. Any option of bailout fund and rescheduling defaulted loans will be regarded as incentives to the defaulters and corrupts."

### TIB for annulment of Power Plant initiative at Tengragiri

TIB expressed deep concern over the setting up a 307MW coal-fired power plant, less than a kilometer off the Tengragiri reserve forest in Borguna without any clearance from Department of Environment (DoE). It urged the authorities concerned to scrap the initiative considering the threat to environment, ecology and life in the surrounding areas.

Referring to media reports that a local firm ISOTECH and two other foreign organizations are setting up a coal based 307 megawatt power plant within a kilometer of Tengragiri forest without DoE clearance, TIB Executive Director Dr Iftekharuzzaman in a statement issued on 7 May 2018 said, ``the coal plant initiative was taken in violation of the section 7 (4) of Environment Conservation Act, 1997 and such a move with the participation of government organization is a matter of grave concern for the country." It is obligatory to obtain the environmental clearance certificate from the DoE before setting up of such industrial units, Dr. Zaman said "It's not fair to set up such plants without receiving the DoE clearance." PDB has already signed a 25-year long PPA to buy power from this plant, he added.

TIB noticed that the process of the project implementation lacked transparency, accountability and coordination.

In October 2010, Tengragiri was declared a sanctuary of wild animals by the Environment and Forest Ministry. The forest has around 40 animal species and different kinds of plants. The forest was once a part of the Sundarbans and declared a reserve forest in 1960. The forest has been playing a vital role in protecting coastal people in large area from cyclones and tidal surges. Despite severe criticism at home and abroad, a 50/50 joint venture of the power board and India's National Thermal Power Corporation is also carrying out implementation of a 1,320MW coal-fired power plant at Rampal in Bagerhat, some 14 kilometers off the Sundarbans.

Tengragiri, known as the second Sundarbans of the country, was declared as a sanctuary of wild animals by the Environment and Forest Ministry in October, 2010. The forest was once a part of the Sundarbans and was declared as a reserved forest area in 1960. The forest has around 40 animal species and different kinds of plants.

Observing the initiative unsafe for nature and lives, Dr. Zaman called on the government to refrain from setting up the plants by violating the Constitution and destroying ecology of the area.

Held in Jashore in participation with the officials of 37 Government institutions, multi-level stakeholders and members of CCC, SWAJON and YES, District Administration and CCC, Jashore organized the meeting on 27 May, 2018 titled 'Sustainable development and Institutional Integrity: Implementing initiatives, Challenges and Opportunities.' The meeting was organized at Jashore





Circuit House Auditorium with a view to strengthen good governance and amplify anti-corruption social movement engaging local level administration, multi-level stakeholders and cross section people of the society.

As the speaker, key Iftekharuzzaman, Executive Director of TIB said that corruption is main restraint for development in our country. It should be restrained by our own initiatives based on our patriotism, ethics and values. He also said that social movement against corruption contributes a lot to strengthen democracy and to achieve the goal of the Independence Movement. Dr. Zaman argued to fight against corruption jointly with local



administration, civil society members, service holders, journalists and young people.

Mr. Abdul Awal, Deputy Commissioner of Jashore district presided over the programme. Mentioning two types of development, he said that human norms and values will be developed along with infrastructural development. Sustainable development will be ensured through this way. Administration will take initiatives to strengthen human norms and values. In open discussion, speakers said that political commitment is needed to ensure good governance. In addition to this, combined efforts of administration and citizens to implement the political decisions are also important. He was delivering speech as chief guest in an opinion sharing meeting with service recipients and hospital authority organized by CCC, Kurigram.

Civil Surgeon of Kurigram district Dr. S M Aminul Islam, Deputy Civil Surgeon Dr. Rezina Begum and Sadar Upazila Health & Family Planning Officer Dr. Nazrul Islam and General Secretary of Kurigram Zilla Shilpakola Academy Mr. Rasheduzzaman Babu were present in the meeting as special guest.



CCC, Kurigram organized the meeting on 15 May 2018 with an aim to improve the quality of services of the hospital. CCC President ATM Enamul Haque Chowdhury presided over the meeting where Convener of CCC's Sub-Committee on Health issues Mr. Sanaul Haque Nantu delivered the welcome speech.



In open discussion session, service recipients expressed experiences their which included irregularities in due time arrival of few doctors, failure in delivering prescribed medicine, prescribing medicine private pharmaceuticals, advising the patients to get admitted in private clinics, attending the medical sales representatives ignoring the long queue of patients etc. The authority answered explained their positions against
