## Journalists of Chakaria Pledged to Fight against Corruption

Jahangir in a presentation shared CCC's ongoing activities, achievements, challenges and the way forward. Mr. Jahangir also shared the initiatives of CCC, Chakaria on education, health, LG, land and climate finance governance to spread out the achievements at the grassroots level.

The journalists pledged to join hands with CCC to strengthen the social movement against corruption to ensure corruption-free Bangladesh. They also assured to helping implementation of Right to Information Act, 2009, the publication of investigative reports against corruption, active participation in anti-corruption activities and organizing joint initiatives etc.







In the open discussion, irregularities and corruption at different service sectors were highlighted. The Journalists pointed out that publication of corruption reports in the newspaper were not followed by corrective measures from relevant authorities. CCC, Chakaria called upon the journalists to take initiatives to encourage people for submitting written complaints accompanying proper evidence to ACC or call ACC hotline on 106 when they notice corruption.

# Road Safety: TIB Criticized and called upon the Government to reform the committee

TIB strongly condemned the government decision to appoint Shajahan Khan, the former Shipping Minister and the President of the Bangladesh Road Transport Workers Federation (BRTWF), as the chief of a 15-member committee that formed to recommend ways on curbing road accidents and bringing discipline to the road transport sector. In a statement issued on 19 February 2019, TIB questioned the Shajahan Khan-led committee, who is "controversial and biased" for his role in curbing road accident. TIB also called upon the government to reform the committee with the prominent and expert person in this sector.

While the government formed the abovementioned committee yesterday, Dr Iftekharuzzaman, the Executive Director of TIB expressed his distress in the statement and said, "It is impossible to hope that the committee led by influential leaders of transport owners and workers' federations can perform their duty neutrally and independently."

In an earlier TIB study on the Road Transport Sector, it reveals this public sector is fully confined by the transport worker and the owners' selfinterest, misuse of power and political influence. The irregularities, arbitrariness, and irresponsibility of the concerns created a dire situation of remaining unfit vehicles, inefficient drivers and their reckless driving posing a serious challenge to ensure peoples' life-security in transport and on-road. However, the existing culture of impunity also hinders the progress to ensure the governance practice.

Refereeing the safe road movement, Dr. Zaman said, "The people especially the youth set an

example of how a safe road should carry on and we all are expecting the government and the concerned authorities would never compromise to any influential to ensure the justice and strict implementation of the rule of law." He requested the government refrain from futile initiative of the controversial committee and not to make those youth hopeless. If any initiative is taken to relax any section of the road transport law, it will be suicidal and against the public interest, he said.

## Thermal Power Plant in Barguna: TIB urged for immediate Stop of the Deal

TIB urged the government to immediately stop installation of the coal-based thermal power plant at Nishanbariya Union of Barguna, which has no clearance from Department of Environment, will pose risk to the ecology and livelihood of locals. In a media release issued on 7 February 2019, TIB called upon the government to cancel the project to be operated jointly by Iso tech Electrification Company Ltd and Power China., terming the project "suicidal".

In a statement, Dr. Iftekharuzzaman said, "Though the court has put injunction over land acquisition following a case filed by victims, activities of the project have resumed with the help of administration and police. Locals who filed cases for compensation are being implicated in false extortion cases, threatened and even being assaulted." He called the authority to refrain from harassing and torturing the local citizens in connection with the project.

Stressing on the issue, Dr. Zaman said, "according to clause 7(4) of the Environmental Conservation Act 1997, there is a legal binding of carrying out environmental impact assessment by a neutral, independent and renowned organization in case of setting up such a facility but it has not been done.

Moreover, without taking clearance certificate from the Department of Environment, the power plant is being set up near Tengragiri reserve forest, which is known as the second Sundarbans."

Expressing deep concern Dr. Zaman said, "Though the land is classified as "Khas" (government) land, some brokers introduced them as owners of the land and are selling those to the companies at a much cheaper rate than the government price. A case was also filed with the court seeking the permanent suspension of both companies, and proper compensation for the affected parties." In this context, Dr. Zaman asked for the immediate withdrawal of project approvals for the proposed 307 MW power-station and initiate effective measure to protect the local land owner's right.

Added, the statement was also shared to the concern Ministry of Environment, Forest and Climate Change and the Ministry of Power, Energy and Mineral Resources. And the request was made to the government on 7 May last year also.

## Law Enforcement: TIB Urges the Police to Discharge Duties without Bias

On the occasion of the Police Week 2019, TIB has called upon the police force to discharge their responsibilities upholding law and ignoring fear and any pressure. The Law enforcement agencies should not be biased or involved in any controversial activities at any circumstance said TIB in a media statement issued on 5 February 2019. TIB also lauded the PM's instruction to the BD police for not to harass- tortured any innocent people at her inaugural remarks in Dhaka.

Dr. Iftekharuzzaman said, "On the occasion of the Police Week 2019, a bundle of demands has been placed before the Honorable Prime Minister, the most are logical, positive and considerable. Therefore, specific initiatives should be assembled with to ensure Integrity in BD Police Forces. We are hopeful over the Prime Minister's firm stance for the anti-drug drive, at the same time we want to be assured that no extra-Judicial killing would happen in the name of 'crossfire'."

Giving importance to peoples' trust on law enforcement agency, Dr. Zaman said, "The people expect that the police would never take any partisan role, and not any special recognition though the controversial role found in the monthlong safe road movement, quota reform movement in the city." And he has called the police department to discharge their duties and responsibilities with professionalism and without any political favour.

Dr. Zaman added, "Transparency, accountability and integrity is an imperative to ensure peoples' security and equal rights for the rule of law, the police officials, convicted for nepotism and misuse of power should be under the law and set an exemplary punishment. This should be a priority to retrieve the people's trust on the law enforcing agency" He suggested the government to increase necessary man-power, capacity and professionalism in the police forces to make this law enforcing agency more effective and public friendly to establish the rule of law.

# Jahalam: TIB Demanded Exemplary Accountability of ACC officials and Compensation

TIB has expressed relief over Jahalam's release from jail as per the High Court's intervention, while he was accused of loan fraud, based on information divulged by Bangladesh Bank and Sonali Bank. Jahalam languished in jail for three years due to wrongful conviction by the ACC officials. In a media statement issued on 4 February 2019, TIB also sought appropriate compensation for his sufferings and urged for exemplary punishment of the involved in wrongful identification of Jahalam.

Expressing his frustration over the mistake by the ACC official, Dr. Iftekharuzzaman said, "The High Court has drawn an end line to an injustice brought to Innocent Jahalam by an order to set him free and investigate of those concerned who made the wrong identification and imprisonment." Financial compensation may be possible but the actual compensation against all the suffering he went through during the last three years is merely not possible, he said.

"The incidents have raised many questions that need to be answered," said Iftekharuzzman, TIB's Executive Director, pointing the impact of the mistake. He said, "The people became trustless on their investigation either it was a mistake or anything fixed to hide the link of the real culprit involved in the Sonali Bank's loan fraudulence. Moreover, we expect the ACC formed would investigation committee carefullv investigate and inform the people on the progress and no repeated mistakes."

Dr. Zaman urged that ACC must ensure the accused in this investigation through bringing accountability if found guilty. No one like Jahalam should be thrown behind bar again and stern action should be taken to get back the people's trust on the ACC.
