Ensure all stakeholders participation & accountability in climate change fund: TIB

The Transparency International Bangladesh (TIB) pushed for the partaking of stakeholders and climate affected people to ensure accountability and transparency in the disbursement of climate change fund.

Speakers at a national level consultation on 'Transparency in climate finance governance' marked that review from the government's part is necessary in the funding policy, project selection and other activity of climate fund to make the process credible and trustworthy.

TIB organized the programme on October 2, 2011 at Bangladesh Institute for Administration and Management (BIAM) auditorium chaired by TIB Chairperson Advocate Sultana Kamal, Chairman of all party parliamentary committee on climate fund Saber Hossain Chowdhury and climate specialist Dr Atiq Rahman was present in the meeting.

TIB Executive Director Dr Iftekharuzzaman presented the key note paper titled 'Transparency and Accountability in Climate Finance Governance: Challenges and Opportunities of Civil Society Engagement'. "We are afraid about the disbursement of climate fund to real climate change affected people and TIB will try to work with the government to ensure transparency and accountability," said Dr. Iftekharuzzaman. Different phases of TIB's new project 'Transparency in Climate Fund management' were unfolded in the discussion.

He told Bangladesh will receive \$100 billion by 2011 for adaptation and mitigation of climate change and the government has already formed a trust of Tk.2100 crore. Transparency and accountably of climate change fund is a must through receiving suggestion from civil society and stake holders, he added. Quotina about Bangladesh Climate Change Trust Fund he said Tk. 453 crore is allocated for government projects which is 96% of the total fund and left 4% will be disbursed by NGOs.

Saber Hossain Chowdhury asked for a couple of model projects engaging parliamentary committee and TIB to establish transparency and good governance in climate change fund. More than 40 stakeholders from different part of the country participated in the consultation along with civil society members. Advocate Sultana Kamal ended the programme asking for an effective bridge between the government and mass people reflecting people's participation in climate change fund.
