TIB observes International Anti-Corruption Day

Transparency International Bangladesh (TIB) observed the International Anti Corruption Day (IACD) with a series of programmes both at the national and local levels. These included sms campaign reaching out to 10 million mobile subscribers of Bangladesh, awards giving ceremony for investigative journalism, rally, seminar and discussion meetings, cartoon exhibition, human chain etc. On December 9, all six mobile operators in Bangladesh carried a public sms of TIB that said: "Corruption increases poverty and injustice, let's fight it together...now—International Anti Corruption Day". It may be mentioned that TIB's sms was sent as govt. Info which is a significant achievement of TIB's advocacy efforts.



In Dhaka, the annual investigative journalism award giving ceremony was held where four journalists received awards in different categories for their reports published/broadcasted in 2012. Veteran journalist A B M Musa, who gave a talk on the challenges of investigative journalism in the current context, urged the journalists to thwart all odds for upholding the spirit of objective journalism in the country. TIB also accorded recognition to three Bangladeshi young photographers who recently brought laurel for the country by winning the 1st, 3rd and a special mention in Tl's global photography competition.

In the afternoon, a human chain was held in front of the Institute of fine arts, University of Dhaka which was followed by the inauguration of a cartoon exhibition. Winners of 2013 cartoon competition were awarded during the programme.

Committee of Concerned Citizens (CCCs) across the country also observed the IACD on December 9, 2013. With an open call for social movement against corruption, a series of programmes including rallies, seminars, conferences, human chains, cartoon exhibitions and other anti





campaigns were organised to observe the day. programmes speakers these participants called upon the government to turn Anti Corruption Commission (ACC) as independent, effective and impartial institution and demanded cancellation of article 32 (2) and 32 Ka that made mandatory provision of takings government's permission to file cases against public servants. They also called upon the citizens to actively engage against corruption. Public representatives; CCC-YES and YES Friends; government and NGO officials; journalists and citizens from


different walks of the society attended these programmes.


CCCs on 9th December also observed the birth and death anniversary of Begum Rokeya Sakhawat Hossain, the pioneer of Bengali women empowerment movement. Speakers remembered her contribution toward empowering women and called upon all to spread her spirit.

Insignificant Improvement in CPI – Bangladesh 2nd lowest in South Asia

Corruption remains a serious global problems according to this year's CPI. 123 countries out of 177 (more than two-thirds) scored below 50 in the index where 108 countries scored equal or less than average of 43. No country has scored 100 which draws the conclusion that no country is corruption free.

Bangladesh has scored 27 points in a scale of 0-100, and has been ranked 136th from the top and 16th from bottom among 177 countries in Corruption Perceptions Index (CPI 2013). This is one point higher than last year's 26, but same as that of 2011. If counted from bottom the raking is three steps higher than that of 2011 and 2012 when Bangladesh was ranked 136th among 177 countries. From the top, this year's ranking is 8 steps higher compared to 144th among 176 countries in 2012. However, both in rank and score among seven South Asian countries Bangladesh's position remains 2nd lowest - lower than all except Afghanistan (score 8, globally at the bottom) while Bhutan tops the list (score 63 rank 31). Except Bhutan all South Asian countries scored much lower than the global average score of 43. Bangladesh ranked at the very bottom for five successive years from 2001-2005. The country then secured 3rd in 2006, 7th in 2007, 10th in 2008, 13th in 2009, 12th in 2010 and 13th position in 2012.









The reasons behind the country's poor performance are grand corruptions and financial scams in stock market, Padma bridge project, Hall Mark, Destiny, Railway, Rana plaza collapse etc. Besides, government interventions for making the Anti Corruption Commission (ACC) powerless, ineffective parliament boycotted by the main opposition, domination of interest groups in parliamentary standing committees, whitening of black money, wide scale grabbing of public lands and water bodies etc. also contributed to poor performance in CPI.

TIB demands probe into unusual rise of wealth of public representatives

TIB expressed deep concerns over unusual rise of wealth of ministers and lawmakers during the tenure of 9th parliament and demanded immediate investigation and subsequent actions by Anti Corruption Commission (ACC). ACC showed reluctances to launch investigation against such unlawful and anti-constitutional act on the ground that, investigation at this point might jeopardize the planned parliament election. A number of media reported this unusual rise of wealth from submitted affidavits to the Election Commission. TIB also criticized the ACC for its unwillingness to take actions.

In a statement issued on 20th December, TIB said that acquisition of wealth inconsistent with known income is illegal and unconstitutional. It hailed media's proactive role in disclosing these information and said that these were naked examples of misuse of power and shocking trend of using public offices for profit. If we let it go, the state would never become accountable and democratic and governance will perish forever, the statement added.

TIB also joined with eminent citizens and condemned Election Commission's evil plot to hide disclosure of wealth related information by parliament election candidates, many of whom were high ranking ministers of the then cabinet and parliamentarians of the 9th parliament. The affidavit revealed that a good number of candidates acquired huge wealth inconsistent with their known source of income.

The statement was issued on 24th December signed by nine eminent citizens that expressed their resentment over EC's move to entrain candidates' demand for not disclosing their affidavit. They added that this was anti-constitutional according to Article 20(2). Such move would undermine peoples' expectation of establishing democratic governance. They observed that it was shocking to see the candidates expressing their dismay over the disclosure to the EC and EC's subsequent actions. People would have zero confident if EC continues this ill motivated move of vindicating legal loopholes in favour of the candidates. They also urged the EC to refrain from such activities as it is also conflicting with the Right to Information Act, 2009.

Dr Akbar Ali Khan was born in Nabinagar of Brahmanbaria district. He attained his MA in history from University of Dhaka; MSS and PhD in Economics from Queens University of Canada. He began his career with the Pakistan civil service

in 1967. During the liberation war he served the Mujibnagar government as a deputy secretary. He served as a teacher after independence and later served as a top level bureaucrat for ten years before retiring as the cabinet secretary in 2001.
